MOVE AIMED AT BRINGING DOMESTIC & OVERSEAS COS UNDER THE TAX REGIME

Payments in Digital Assets in Casinos, Online Gaming to Face GST

New Delhi: Payments or winnings received in Virtual Digital Assets (VDA) in casinos or online gaming will face goods and services tax, according to the rules likely to be taken by the Goods and Services Tax (GST) Council on August 2, officials said

The move is aimed at bringing both overseas and domestic online gaming companies which accept and make payment in VDAs such as cryptocurrency under GST. The GST council, which approved a 28% levy on July 11 on online gaming, casinos and horse racing, on full face value, will meet virtually on August 2, to clarify the definition of online

gaming. It is likely to provide a clear definition of "online gaming" and "online money gaming" by amendment in the CGST Act to rule out any future discrepancy, officials said. According to the officials, online money gaming is expected to be defined as online games where players pay, deposit or receive money

or money's worth, including virtual digital assets, in the expectation of winning money. This will also cover any experience or any kind given to players, which will be equivalent to the monetary value of that gift or experience offered to player as "prize". This will also define GST for casinos and online casinos, which transact in virtual digital assets, officials said.

"Considering now we have our own CBDC (Central bank digital currency), it is important to include it in definition," an official told ET. However, considering difficulties in determining the full face value in cases where the player is using previous winning amount for another game, the council decided to meet again on August 2.

Indian Oil Posts ₹13,750-crore Net on Strong Sales in June Qtr

New Delhi: Indian Oil Corp has reported a profit of ₹13,750 crore for the April-June quarter, compared to a loss of ₹1,992 crore in the year-ago period, on extraordinary fuel sales margin. The revenue from operations fell 12% on-year to ₹2,21,145 crore. The June-quarter profit was 37% higher sequentially.

The gross refining margin fell to \$8.34 per barrel during the April-June period from the extraordinary level of \$31.81 per barrel in the year-ago quarter. The Ukraine war and the consequent western sanctions on Russia had driven the refining margins to extremely high levels last year.

The biggest contributor to Indian Oil's profit was the marketing margins on petrol and diesel. The company doesn't separately report marketing margins but brokerages estimate that the oil marketing companies made an average profit of ₹9.9 per litre on the sale of petrol and diesel at pumps during the quarter.

While international fuel prices have dropped, oil marketing companies like Indian Oil, HPCL and BPCL haven't cut pump prices, leading to extraordinary marketing margins. BPCL has reported a profit of ₹10,550 crore for the April-June quarter compared to a loss of ₹6,263 crore in the year-ago period.

Indian Oil shares closed 0.33% lower at ₹5.28 apiece on BSE on Friday.
