Petronet LNG Q2 Profit Dips 5%, Revenue Falls 15%

New Delhi: Petronet LNG reported a 5% year-on-year decline in net profit to ₹696 crore for the July-September quarter, reflecting lower utilisation at its regasification terminal. Revenue from operations fell 15% to ₹11,099 crore.

The company handled 228 thousand British thermal units (BTU) of liquefied natural gas (LNG) in the July-September period, compared with 239 BTU a year earlier. Utilisation at Petronet's flagship Dahej import terminal in Gujarat slipped to 95% from 98% in the year ago quarter.

A drop in domestic natural gas consumption and LNG imports—driven mainly by lower demand from the power sector due to a milder summer—affected terminal utilisation this year, chief executive AK Singh said. Singh added that if LNG prices—currently around \$11 per mmBtu—become more

affordable, both consumption and imports could expand rapidly. Petronet is targeting completion of the Dahej terminal expansion by March, which will add 5 million tonnes per annum to its regasification capacity. Once completed, Dahej's total capacity will rise to 25.5 million tonnes per year.

JSW Cement Swings Back into Black

India's JSW Cement reported a second quarter profit on Friday, as it dispatched more volumes of the construction material at higher prices. The volume growth comes in a seasonally weak quarter when India's annual monsoons slow construction activity, weakening demand for the material. Consolidated total net profit for the July-September period came in at ₹964.3 million (₹8.8 million).

Compared with a loss of ₹943.9 million a year ago, Shares of JSW Cement closed 0.6% lower on Friday. They are roughly 1% down since their listing in August. Cement prices have steadily recovered from lows hit in 2024 when demand took a hit from a slow pace in construction activity, especially in infrastructure projects, following the country's general elections. — Reuters

Kalyan Jewellers Q2 Net Doubles

New Delhi: Kalyan Jewellers India on Friday reported a twofold jump in its consolidated net profit to ₹260.51 crore in the September quarter on higher income. Its net profit stood at ₹130.32 crore in the year-ago period. Total income grew to ₹7,307.44 crore during the July-September quarter of the current 2025-26 financial year from ₹5,091.47 crore in the corresponding period in the preceding year, according to a regulatory filing. — PTI
